PANEL DISCUSSION

THEME: THE POLITICAL LANDSCAPE IN SA AND THE INFLUENCE ON OUR ECONOMY AND CORRUPTION

PROF ANDRE ROUX

Prof André Roux is head of the Futures Studies programme at the University of Stellenbosch Business School. Before being appointed by Stellenbosch Business School, he was Director of the Institute for Futures Research (IFR) at the University of Stellenbosch since 1996.

In that capacity, he ran various workshops and other strategic intervention sessions with and for leaders and strategists in business and government. Before that, he was an economist at the insurance company Old Mutual, a lecturer and head of department in the South African National Defence Force and its predecessor, the South African Defence Force, as well as a junior lecturer at Stellenbosch University.

Prof Roux's areas of expertise are business economics and labour economics. His research focuses on globalisation and socio-economic development in Africa. He is a member of the management committee of the Bureau for Economic Research and holds a BCom, a Hons BCom in Economics, an MCom in Economics and a PhD, all from Stellenbosch University. He lectures on economics and future thinking at SBS-ED and on various executive education programmes in South Africa and, from time to time, in Australia, Namibia, Swaziland, Tanzania, Ghana and Nigeria.

He is a guest lecturer on a number of postgraduate programmes at Stellenbosch University and has lectured on the course in economics presented to MBA students at the Vlerick-Leuven-Gent Business School in Belgium since 2009. Prof Roux is responsible for more than 130 popular publications, a book (9th edition), and has published in academic journals. He is very popular as a presenter and won the Best Lecturer Award in Stellenbosch University's Faculty of Economic and Management Sciences in 2016.

ARTHUR KAMP

Current responsibilities: Arthur Kamp is Chief Economist of the Sanlam Investment Group (joined 2005), providing economics analysis on the South African and global economy, including African economies ex SA, for the Sanlam Investment Group.

Also, during this period: External Moderator, University of Stellenbosch, Post - graduate Financial Market Analysis Module, Department of Economics, 2011-2013. Currently a member of the Academic Advisory Board for the Department of Economics and Finance, University of the Free State.

Previous experience: Prior to Sanlam Investments, Kamp worked as an economics consultant at Eskom from 1990 to 1995 and thereafter spent 10 years working as an economist at stock broking firm Simpson McKie and the global investment bank, HSBC. During this time, he was responsible for HSBC's South African economics product offering.

Academic: Kamp holds a Hons. B-Econ (Economics) Cum Laude degree from the University of Stellenbosch and a MSc. Financial Economics degree from the University of London.

DR DELANO COLE VAN DER LINDE

Dr Delano Cole van der Linde is a senior lecturer in the Department of Public Law at Stellenbosch University (SU). He lectures Law of criminal procedure and advanced criminal law at undergraduate level and a module on organised crime at postgraduate level. Before joining the SU Faculty of Law, Dr Van der Linde taught at North-West University where he taught several modules, including criminal law (general principles and specific crimes) as well as legal interpretation. He also served as Subject Chair: Criminal law and Criminal procedure law. Dr Van der Linde's main fields of research is organised crime and cybercrime. He has published several peer-reviewed articles in this field. His doctoral dissertation, "Criminal gang activities: A critical and comparative analysis of the statutory framework under South African criminal law", wherein he advocates for legislative reform, details the textual, procedural, institutional, and constitutional issues surrounding Chapter 4 of the Prevention of Organised Crime Act 121 of 1998. He is currently a board member of the Pavocat Stellenbosch Academy, on the editorial board of the Journal of Contemporary Roman-Dutch Law, and a member of the Society Hugo de Groot. Dr van der Linde is also a contributor for South African Criminal Law and Procedure (Volume III: Statutory Offences). He has received funding from the National Research Foundation to conduct postdoctoral research, which enabled him to expand on his doctoral research.

RYAN RAVENS

Ryan Ravens is the CEO of Accelerate Cape Town, representing top-tier corporate business in the Cape Town city region; as well as Chairman of Amaya Space – a startup established to commercialise innovation from the CPUT spacetech program.

He currently holds three degrees including an MBA from the University of Cape Town (UCT), in addition to numerous globally recognised professional certifications such as CIPM and PRINCE2.

A life-long entrepreneur, Ryan owned and managed a successful management consultancy for a number of years before he was approached by FIFA in 2006 to develop and implement the masterplan for the 2010 World Cup.

Following the successful delivery of the FIFA 2010 World Cup, he served as a Group Executive for the Gauteng Growth & Development Agency, before returning to his entrepreneurial roots with investments in numerous start-ups including solar renewables, large-scale project advisory services, and cloud-based software development, before moving to Cape Town in 2015 to take up the Accelerate role.

Ryan has extensive experience in leadership positions across both public and private sectors, has worked in all the major SA cities, as well as geographically diverse regions such as Shanghai, Lagos, Doha, and Zurich. Ryan believes in the power of education to transform lives and is passionate about making a positive difference in the SA socioeconomic landscape.
